I responded to a report of men with guns at the Pizza Hut on Prince Ave. It seemed that there were at least two callers and there were reports of it being real guns or toy guns. Upon arrival I saw one male with a striped shirt and khaki pants as one caller reported. He held something in his right hand. As I arrived he seemed to twist his body to block my view. It appeared to be a firearm. There was another person right behind him wearing grey. It looked like he had the butt of a gun sticking in his pants. I drew my firearm and ordered them to the ground. They complied and were detained. The guns were paintball guns and other than hanging out with an employee at Pizza Hut who was about to be done with work they did not appear to be shooting at cars or attempting a robbery. They were cited for a curfew violation and the younger one was turned over to his mother. The 17 year old was released. A delivery driver was on scene after the incident who had a real firearm but it had no involvement in this call.
